By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Sponsor, which shall be final and binding in all respects.

ELIGIBILITY

The Sweepstakes is open only to State Health Benefit Plan Members enrolled in a UnitedHealthcare Medical Plan. Void where prohibited or restricted by law.

Sponsor, in its sole discretion, will attempt to contact potential winner of a prize in accordance with the above procedure, after which the prize in question may go unawarded if it remains unclaimed.
